Introduction

- 1. Welcome & Introductions Lu Harvey Lewis TAC Chair
 TAC Chair Mr. Lu Harvey Lewis (Middlesex) called the meeting to order. Mr. Lewis welcomed and thanked everyone for attending the meeting.
- 2. Mr. Lu Harvey Lewis asked if any members have a conflict of interest on any of the items on the agenda. There being none.
- 3. Minutes March 11, 2020
 After reviewing the Minutes for the March 11, 2020 meeting and **UPON A MOTION** by C. B. Brown (Tarboro), second by Oscar Mabry (Pinetops) they were unanimously approved.

Presentation

4. Eastern NC Freight Mobility Study, Dana A. Magliola, NCDOT Planning/Logistics
Dana Magliola with NCDOT Logistics provided a introduction into NCDOT's Office of
Logistics and Freight. He provided detailed information on the supply chain and freight
behavior viewpoints detailing specifics for the UCPRPO region and the Eastern NC Regional
Freight Mobility Plan. Discussion included rail, truck, air, and port modes of transportation.

Action Items

5. Chair/Vice Chair Nominations and Election for FY2021 Nominations were opened up to members. After the nominations of Lu Harvey Lewis (Middlesex) as Chair and C.B. Brown (Tarboro) as Vice Chair and UPON A MOTION by C.B. Brown (Tarboro), second by Ted Godwin (Johnston) Lu Harvey Lewis (Middlesex) was elected as Chair and C.B. Brown was elected as Vice Chair.

Discussion

6. STI P6 Prioritization Update – Submitted Projects/Prioritization 6.0 (P6) Revenue Memo Members were provided with the memo dated July 30, 2020 from Van Argabright Director for the Division of Planning and Programming at NCDOT stating it is anticipated that very little funding available for programming for STI P 6.0. It will be very difficult to get projects funded for this round of prioritization. The process will continue to move forward at this time. Members were updated on the next steps and key deadlines.



7. STIP FY2020-2029 Amendment Updates

On August 17, 2020, NCDOT released a proposed Amendment to the FY2020-2029 STIP that made sweeping schedule changes for a majority of projects. Key projects were highlighted with revised construction start dates.

8. Traffic Survey Data/COVID-19

Mr. Salmons provided a brief presentation on the effects of COVID-19 on traffic within the State of North Carolina. It was reported at the height of the Stay at Home Order, traffic decreased by more than 40% and has caused extreme reductions in transportation funding. The presentation included effects of COVID-19 on NC greenways and crashes on state highways.

- 9. Legislative Update HB 77 and JLPEOC Report

 Members were provided a brief report on the recently passed HB 77 balancing NCDOT's budget and the Joint Legislative Program Evaluation Oversight Committee meeting held August 10, 2020 in reference to the Department's over spending and recent audit completed by the NC State Auditor.
- 10. Members were informed that Gus Tullos is stepping down as Division 4 BOT member. The new Division 4 State Board of Transportation is Mr. Melvin Mitchell from Rocky Mounthttps://governor.nc.gov/news/governor-cooper-appoints-members-board-transportation

It was reported the US 70 Commission has not met since January 23. 2020 due to COVID-19. Members were provided with a US 70 projects report provided by the Commission.

2. Hwy 17/64 Association

Hwy 17/64 Association last met virtually July 29, 2020 where they provided an update on NCDOT financial status. The next Association meeting is scheduled to be held virtually on September 20, 2020 which will provide a good opportunity for members to attend without having to travel.

3. Legislative Update

A brief report was provided on the recently passed HB 77.

4. NCDOT Division 4

Division 4 reported that HB 77 will allow the Department to fund projects from Bond money and allow the Department can build up some money. It also allows the Department to build up some maintenance. The Department is in a wait and see mode to see how/if COVID-19 continues to affect the budget and how it may affect STI P6. The I-95 project in Benson is still on the schedule for July 2021. However, the project still has not been opened up for R/W as of yet.

5. NCDOT Planning Division (TPD)




State Transportation Improvement Program - planning document listing most capital projects NCDOT expects to deliver over next 10 years







Dear James,

Last week, the North Carolina Council of State **approved** a purchase of \$700 million in Build NC Bonds that will allocate funds to the N.C. Department of Transportation for immediate road repair and construction needs across the state. Authorized through **House Bill 77**, a pro-business bill that passed with the NC Chamber's support during the 2020 session, the bonds will primarily be used to pay for projects that have regional impacts and will be repaid through the state's Highway Trust Fund. State Treasurer Dale Folwell and the State and Local Governance Finance Division (SLGFD) announced that the bonds are expected to be issued by the end of October.

Approval of the bond sale – which comes at a time when interest rates are at historic lows – is welcome news for North Carolina's job creators, who depend on a well-funded transportation network to operate efficiently. However, the business community must continue to focus on providing long-term solutions to our funding challenges if we hope to secure a truly modernized revenue formula that can proactively strengthen our ability to invest in our transportation future.

To that end, the NC Chamber is leading a fast-growing alliance of businesses and growth-minded organizations, the **Destination 2030 Coalition**, in a series of conversations to help us determine the transportation solutions we will support on the business community's behalf in 2021. 







Tracking Trends

- Two types of statistics are being tracked to characterize the changes in travel:
 - Volume Trends % Change between Pre COVID-19 volume and current volume
 - Travel Trends Change in vehicle miles traveled (VMT) between 2020 Forecasted VMT and 2020 Actual VMT estimates
- Calculations are made by day of week due to the normal variation in daily travel occurring in a week
- Change is calculated for each continuous count station (CCS)
- Daily statewide volume change is based on the average CCS change
- Volume trend is based on the early March 2020 Pre COVID volumes
- Travel trend is based on 2019 volumes for the same month.
- 2020 Actual VMT is estimated by applying the average daily % change to the 2019 daily VMT estimate


Key Dates

The following dates for actions taken by the state to mitigate the impacts of the COVID-19 virus are key to the changes in travel:

- March 10th Emergency Declaration (Week 2)
- March 14th Close public schools (Week 2)
- March 17th Close bars and prohibits dining in restaurants (Week 3)
- March 30th Stay at Home order implemented (Week 4)
- May 8th Phase I reopening initiated (Week 10)
- May 22nd Phase II reopening initiated (Week 12)


We are tracking volume trends weekly and the week indicated for each date is the first full week after the action was implemented.

Volume Trend – Weekly Change




Weekly Change: Average of daily changes from Pre COVID volumes

Compares variation of impacts by the type of route


Travel Trend – Based on VMT

A statistic used to measure travel is Vehicle Miles Traveled (VMT). It is generated by multiplying the length of a highway segment with its volume. The VMT travel reported for 2018 are:

- US VMT was about 3.3 Trillion
- NC VMT was about 121 Billion
- Average monthly NC VMT was about 10 Billion
- VMT varies by Day of Week
- Lowest travel day in NC is typically Sunday around 300 Million
- Highest travel day in NC is typically Friday around 420 Million

Statewide Daily VMT will vary due to seasonal variation, holidays, adverse weather, and major events.

As of October 10th we have 15.6 Billion less VMT than forecasted
